Product certificate.

The certification test is to be performed at the manufacturer of the application system according to an approved test program before the system is shipped to the yard. After the certification the clause for application software control will be put into force.

Clause for application software control.

All changes in software are to be recorded as long as the system is in use on board. The records of all changes are to be forwarded to DNV for evaluation and approval. Major changes in the software are to be approved before being installed in the computer.
